---

Jason began working on the legislative changes in 2008 with the FYBA. In March 2010, he testified in front of the Florida Senate on behalf of the Florida Yacht Brokers Association, Marine Industries Association Florida and the Marine Industries Association of South Florida. June of 2010, the Florida legislature capped sales and use tax at \$18,000. Jason has addressed Fort Lauderdale City Council on behalf of the Marine Industry of South Florida, along with meeting and addressing the interests of the marine Industry to many elected State and Federal officials.
